^{*} If a container is not returned in the condition required or within the prescribed free time to the specified empty container facility, or the export terminal,

^{*} Containers that are released from a ONE Depot for export but which are not used and which are subsequently returned to the ONE Depot after a 5 free day period are subject to container detention, from the date of collection of the empty unit until the date the unit is returned to the ONE depot, as well as 'Container Released to Shipper but Returned to Depot Not Used' fee. Please also note Booking Cancellations Fees apply when ONE receive a request, during normal business hours, to cancel, reduce, roll-over or transfer an export booking on or after the first day of the export receival period at the terminal.
